## OUR VISION

Every child at Fladbury will know they are loved by God, have a happy heart and be part of a flourishing, well-led school. When they leave Fladbury, they will be well-prepared to meet challenges, confident in their abilities and look forward to their bright future with an open mind.

Our policy on school uniform is based on the notion that school uniform:

- promotes a sense of pride in the school
- engenders a sense of community and belonging towards the school
- is practical and smart
- identifies the children with the school
- makes children feel equal to their peers in terms of appearance
- is regarded as suitable wear for school and good value for money by most parents

## **Cost**

The 'Cost of School Uniforms Guidance (November 2021) states -

*"Parents should not have to think about the cost of a school uniform when choosing which school(s) to apply for. No school uniform should be so expensive as to leave pupils or their families feeling unable to apply to, or attend, a school of their choice. Therefore, schools need to ensure that their uniforms are affordable".*

## **Branded Uniform**

A small number of items within our school uniform can be bought branded with our school logo and name. This is an option for parents and not an expectation. These branded items are kept to a minimum and do not include items such as coats or shoes which families might purchase for use both within and outside of school.

Branded items are available from *The School Shop* in Evesham. Preschool branded items are available from the school office.

## **Non-Branded Alternatives**

All of our branded items are available in non-branded alternatives. Our uniform is in generic colours to ensure that non-branded items are easily accessible from high street stores, including those which sell uniform at lower prices such as supermarkets.

There will be no discrimination made between children who wear branded/non-branded items to school.

## **Second Hand Uniform**

Volunteers from the P.T.A. organise second-hand uniform sales, normally towards the end of the summer term. Items are donated by our families and are of good quality. They are either available free of charge or for a voluntary contribution.

## **Equality**

This Uniform Policy pays regard to the actions schools must take resulting from the Equality Act (2010). The Equality Act does not refer directly to uniform but stipulates that no group with restricted characteristics must be discriminated against in the purchase of or access to items of uniform.

The uniform is the same for both genders and families may choose from the same list of items for both boys and girls. We endeavour to ensure that our uniform is as gender neutral and inclusive as possible. We do not insist that children of any sex must wear specific items of clothing.

School will be sensitive to the needs of different cultures, races and religions and act reasonably in accommodating any adjustments to uniform which are required to comply with a child's religion or belief.

These adjustments cannot compromise important school policies, such as school safety or discipline. The school and governing board will act reasonably through consultation and dialogue in accommodating any uniform adaptations at parents' or pupils' request.

### **Expectations for school uniform**

Our school's uniform:

#### **Preschool**

Red polo style shirt  
Navy blue pull-on shorts or navy blue jogging bottoms  
Navy blue sweatshirt

#### **Reception – Year 6** **Winter Uniform**

Navy blue sweatshirt or navy blue cardigan  
Pale blue polo style shirt  
Grey long or short trousers  
Navy blue skirt or pinafore dress  
Grey or navy blue socks or tights  
Black shoes  
Optional - navy jogging bottoms if cold for outside use only

#### **Summer Uniform**

Pale blue polo style shirt  
Grey short trousers  
Blue gingham dress  
Grey or white ankle socks  
Optional - red baseball hat (correctly worn) for sunny days.

#### **P.E. Kit (Winter and Summer)**

Navy blue T shirt  
Navy blue shorts  
Navy jogging bottoms  
Navy zip up hoodie or plain navy sweatshirt  
White socks  
Trainers (laces or Velcro) for outdoor and bare feet for indoors  
Swimming costumes and towels (If goggles are worn parents must provide a letter confirming they understand possible risks)

Pupils are permitted to wear one pair of stud earrings which must be removed for P.E.

All long hair must be tied back at all times for health and safety reasons

**Non-Compliance**

As school uniform has been identified as an important factor in developing our strong community and pride in our school and ourselves, non-compliance will be addressed. However, due to the age of the pupils this will be done sensitively.

Children will be given verbal reminders about compliance when in school, especially with aspects of uniform which relate to health and safety. These will be delivered to whole groups as 'reminders' or individually where they will be dealt with politely with an explanation given of how the uniform is not following the expectation and how this can be improved.

Any significant concerns will be raised with parents as parents are responsible for providing uniform and will be accompanied by offers of second-hand uniform or support with sourcing uniform at a reasonable cost.

**Information for parents**

Information for parents will be kept up-to-date on the school website and reminders will be regularly placed in the school newsletter. Parents will be directed to the Headteacher with any individual concerns relating to the purchase of, adaptations to or compliance with school uniform.
